Why we chose pro-active education as a means?

The work force, the major chunk of the society, sustains our life by producing food to eat and provide all that we need to live. The workers who toil day and night deserve time and money to live. Sadly, they always remain the least paid and the most exploited. They face unemployment, servitude and abysmal poverty. Those who grow food for us are left to starve. The weavers are left to fend for themselves without proper clothing even to protect them from the hot sun or from the biting cold. These hapless people solely depend on government schemes for their basic amenities viz. safety, security, health, education, transport etc. They are deprived of proper education, employment and ultimately an honourable living mainly because of the illegal activities of the law breakers and frauds. Social workers and Activists were not successful in alleviating their misery. There is an urgent need to address the plight of these marginalized, lest they would cease to exist. Wrong doings are to be effectively prevented, good attitude and deeds encouraged and the bad to be purged from the society.

Big and small doles on the eve of calamities or celebrations were never enough to contain hunger of a sizable population around the globe. In the constitution of U.S.S.R. work is a duty and a matter of honour for every able-bodied citizen, in accordance with the principle: "He who does not work, neither shall he eat." a biblical aphorism found in II Thessalonians 3:10. The first man Adam was given work to tend and care the Garden of Eden. It would be ignominious to live without contributing literally anything in return for the food one eats. Work adds meaning and dignity to life.

That apart, even those who are willing and able, go without work for a larger part of the year and the working class is reeling under pressure of exploitation doing more work for a meagre wages just to eke out a living. Self employment in agriculture or trade or industry is literally becoming impossible for those who choose to do in a just and fair manner. They are denied of their legitimate right to live a honourable life. The law enforcement officials are losing ground due to various reasons and ultimately law could contain nothing because of the repeated dents, leaks and holes made over a period by the lawless greedy people. Better living conditions, better education and better health are a farfetched dream. Wars and weapons of the mighty and powerful did not bring in any permanent solution or lasting peace.

Why we chose education: Instead, education has shaped many a civilized society. Pro-active education on legal matters would certainly create attitudinal change at least in some of the educated persons who flout the law with impunity only because the atmosphere is conducive to escape punishment as a result of liberalization and relaxation of rules and procedures. They would come to know that what wrongs they do is being noticed by the people as well as the executives and they could no longer pretend to be good while continuing to do shameful illegal acts. A paradigm change is the need of the hour. Taking

away a larger chunk in the guise of 'free giving' is to be stopped. The best gift one could give is 'not to retain or take away what is due to the other – to Caesar what is Caesar's and to God what is God's – nature and all creatures therein and not waste what is useful to the next person or generation'. It would be far better to sensitize the law breakers on the extent of damage and deprivation their self centred acts cause to innumerable people, endangering the very existence of the planet earth. This could be achieved by a mass movement of sharing knowledge towards achieving equality and justice.

Problem focused and solutions proposed – Project Lay Out

We are indebted to all those who provide us all that we need to live because our life and happiness greatly depend on them.

Problems Focused: Commitment to law and justice makes people civilized and prosperous. It is the quality of governance which would make the difference in people's lives. A community is known by the way it treats vulnerable sections of society. Nobody would sow or plant amongst weeds and thistles. A few greedy persons, who do not even love themselves and some, who choose violence as means to achieve their ends, are the cause for today's overwhelming angst and insecurity. Moreover, they nullify the developmental and relief work done by governments and social organizations. Today, a single individual, if not prevented effectively, might harm thousands at a stroke, abusing technology. In countries like India, many illegal activities go undetected and the frauds could escape punishment with ease. Even where cases are registered, hardly 30% succeed. The space for fair play shrinks faster. Due to illegal competition, those doing legitimate business are either tempted to abandon their commitment to being just and right or marginalized and ultimately pushed out of business. This results in widespread injustice and its ill-effects. It appears that we are in the eleventh hour. Something has to be done very urgently, at least to have a respite and to delay the doomsday by a few generations.

Solutions Proposed: Better law enforcement would address the core problem. It would protect legitimate business from illegal competition and more people would opt for legal ways to earn. Genuine business will flourish generating more employment. There would be a dent in fund flow since most of the organized violence is funded by those engaged in unlawful activities – willingly or under duress. This would act as a contributing factor for the splinter groups to look for solution in lawful ways of non-violence. There will be an increase in tax compliance resulting in more revenue for the Government available for developmental works, triggering reduction in tax. Due to better law enforcement, wrong doings will be effectively prevented; good attitudes and deeds will be encouraged and thus bad would be purged from society.
